The Member Discount \$500 gift card for Target, Dell Computers, or AAA Travel Contest. Contest begins January 12, 2010 and ends February 28, 2010. Sponsored by AAA Arizona, Inc., 3144 North 7th Avenue, Phoenix, AZ 85067-3119 (the "Sponsor").

1. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

2. ELIGIBILITY. United States law governs this Contest. From the time of entry through the final date of prize fulfillment, each contest entrant and winner must be a legal resident of the State of Arizona and 18 years of age or older. **VOID IN ALL JURISDICTIONS WHERE PROHIBITED OR RESTRICTED BY LAW.** Employees, officers, directors, agents and representatives of AAA Arizona, their respective parent companies, affiliates, subsidiaries, advertising and promotion agencies, promotion partners and any entity involved in the development, production, implementation, administration or fulfillment of this Sweepstakes and the immediate family members (e.g., spouse, mother, father, sister, brother, uncle, aunt, nephew, niece, grandparent, in-law, daughter and son, regardless of where they live) and persons living in the same household (whether or not related) of such individuals are not eligible to participate or win. AAA Arizona, 3144 N. 7th Ave, Phoenix, AZ 85067-3119.** Postcard may also be received in person at the above location by February 28, 2010 at 12:00 noon MST. Only one entry per household will be accepted. Only one gift card for one location will be awarded to one individual.

4. SELECTION OF WINNERS. The winner will be selected on or about March 15, 2010, by random drawing of all eligible entries received. The random drawing will be held under the supervision of the Sponsor, whose decisions shall be final in all matters. The selected entrant will be notified by phone or mail and may be required to complete, execute and return an affidavit of eligibility and liability/publicity release ("Affidavit"). Failure by the selected entrant to sign and return any such forms within 2 days of delivery to his or her address via Federal Express envelope (to be sent to the winner by the Sponsor) or the return of notification, prize information or the prize as undeliverable may result in a disqualification of the selected entrant as a potential Prize Winner. Upon any such disqualification, an alternate sweepstakes entrant shall be selected by random drawing conducted by the Sponsor. Prizes are not transferable, and no cash or prize substitution is allowed. Only one entry per household will be accepted. Only one gift card for one location will be awarded to one individual.

6. **ODDS OF WINNING. MANY WILL ENTER. FEW WILL WIN.** Odds of winning a prize are determined by the total number of eligible entries receive.

7. **RESTRICTIONS.** The prize package consists of only those items specifically described as part of the prize package. The Sponsor shall not be responsible for any cancellations, delays, diversions or substitutions or any act or omissions whatsoever by the performers/events, rail carriers, hotels or other transportation companies or any other persons providing any of these services and accommodations to passengers, including any results thereof such as changes in services or accommodations necessitated by same. If the winner becomes disabled or cannot otherwise fully enjoy the sweepstakes prize package due to illness, the Sponsor shall have the option of: (1) being relieved of liability for fulfillment of the prize award or (2) may, at its sole discretion, extend the period during which such prize may be awarded for a period equal to the duration of the winner's disability or illness. 9. **ARBITRATION.** Except where prohibited by law, as a condition of participating in this Sweepstakes, entrant agrees that (1) any and all disputes and causes of action arising out of or connected with this Sweepstakes, or any prizes awarded, shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration under the rules of the American Arbitration Association and held at the AAA office in Phoenix, Arizona; (2) the Federal Arbitration Act shall govern the interpretation, enforcement and all proceedings at such arbitration; and (3) judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will any entrant be permitted to obtain awards for, and each entrant hereby waives all rights to claim, punitive, incidental or consequential damages, or any other damages, including attorneys' fees, other than entrant's actual out-of-pocket expenses (i.e., costs associated with entering this Sweepstakes), and entrant further waives all rights to

have damages multiplied or increased. The parties shall split all AAA's charges associated with the arbitration and the parties shall bear their respective other costs and attorneys' fees. The arbitrator shall apply, as applicable, federal or Arizona substantive law and law of remedies. The parties shall be entitled to discovery of essential documents and witnesses as determined by the arbitrator. In reaching a decision, which shall set forth in writing the basis therefor, the arbitrator shall have no authority to change, extend, modify or suspend any of the terms of these Official Rules, but shall have the authority to order injunctive and/or other equitable relief. A judgment upon any award rendered by the arbitrator may be entered in any court having jurisdiction. Any party may bring an action in any court of competent jurisdiction, if necessary, to compel arbitration under this arbitration provision, to obtain preliminary relief in support of claims to be prosecuted in arbitration or to enforce an arbitration award.
