HONEYMOON REGISTRY SERVICE

Terms of Use

These Terms of Use constitute a binding agreement between (i) the person (s) ("Client") utilizing the services of The Gift of Travel Honeymoon Registry Service, i.e. bride, groom and couples and (ii) AAA Arizona, Inc. These Terms of Use apply to the use of The Gift of Travel Honeymoon Registry Services by AAA Arizona, Inc. (the "Registry") and all features related to the Registry and its related services. All fees, chargeback's and other related miscellaneous cost associated with the Registry, from origination and beyond, are the responsibility of the Client. Electronic and paper Gift certificates issued are the property of AAA Arizona, Inc. and can only be used at certified AAA Arizona, Inc. locations for travel products. All Gift of Travel Electronic Gift Certificate purchases will be applied directly to the Client's Registry account. Electronic Gift Certificates have **no cash value** and can only be refunded to original purchaser on the original form of payment. The Client at any time may close the Registry service by written notification to AAA Arizona, Inc. Notifications to AAA Arizona, Inc. website will take approximately three business days to discontinue Registry service.

Electronic Gift Certificate:

Guests contribute to the client's Gift of Travel account by purchasing electronic gift certificates. The client may apply the total electronic gift certificate value to the honeymoon package or towards a Paper Gift Certificate.

Paper Gift Certificate:

A Paper Gift Certificate is generated when there is a residual value left on the client's Gift of Travel account after the honeymoon purchase has been finalized. A Paper Gift Certificate may be used towards the purchase of a future cruise or tour and towards travel store products sold at AAA Arizona, Inc. stores

I.) Eligibility

- a. In order to utilize the services of the Registry, the Client must officially open a Registry with a AAA Arizona, Inc. Honeymoon Specialist by placing the required **deposit** on a selected honeymoon package. The deposit will be applied towards the cost of the honeymoon package. Travel bookings made prior to the opening of a Registry are not applicable to Registry. These Terms of Use shall be deemed accepted by the Client at the time of Registry opening.

2.) Conditions of use:

- a. Client must be at least 18 years of age.

- b. Client understands that the honeymoon package must have a minimum total cost of \$1000.
- c. Client understands that the honeymoon package must be prepaid.
- d. Client understands that the Registry may not be used for airline tickets only.
- e. The Registry will retain 4% of the value of the gift contributions as a processing fee.
- f. Gift of Travel Electronic Gift Certificate(s) purchases on AAA Arizona, Inc. internet site will be accepted until the earlier of: (1) the Client's scheduled honeymoon date, or (2) until notification is received from the Client to discontinue the Registry service and close the Registry. Registry closing is non-reversible. If, additional payments are made by Client or received from Electronic Gift Certificate (s) purchases on AAA Arizona, Inc. website and the total Registry account exceeds the final payment amount due to vendor(s) a AAA Arizona, Inc. "Paper" Gift Certificate will be issued to the Client for the difference at Registry closing. After the Gift of Travel Electronic Gift Certificates have been applied, all final payment amounts due are the responsibility of the Client. An overage amount may exist, due to functional processing timeliness for Internet transactions; and/or changes to original honeymoon package pricing (voluntary or involuntary); and/or additional payments made on the honeymoon package. The Registry will be finalized 1 business day after the wedding date.
- g. Final payment on Client honeymoon is due 60 days to 90 days prior to departure, based on the vendor policy.
- h. All Gifts of Travel "Paper" and Electronic Gift Certificates purchased in name of the Client can be applied towards travel store products sold at AAA Arizona, Inc. stores.
- i. The Client is responsible for any remaining travel package balance due to vendor (s).
- j. Remaining Gift of Travel Electronic Gift Certificate(s) purchases in excess of the final payment amount due to vendor may be applied to auxiliary items i.e. destination activities, ship board credit, AAA Arizona, Inc. Travel Store purchases, upgrades or issued in the form of an AAA Arizona, Inc. "Paper" Travel Gift Certificate. Traveler's checks and cards cannot be purchased with AAA Arizona, Inc. "Paper" Travel Gift Certificates.
- k. AAA Arizona, Inc. reserves the right to modify these Terms of Use. Such modifications will be effective once posted to AAA Arizona, Inc. website.
- l. AAA Arizona, Inc. Cruise Bank program and other discount coupons are NOT combinable with The Gift of Travel Registry Service.
- m. AAA Arizona, Inc. reserves the right to cancel a Registry at any time.
- n. All AAA Arizona, Inc. Gift certificate(s) Gift of Travel Electronic Gift Certificate(s) or "Paper" Travel Gift Certificates) have no cash value and can only be refunded to the original purchaser on the original form of payment. Gift certificate(s) cannot be transferred to another client or a different name. Gift certificate(s) are not redeemable for cash and change will not be returned. "Paper" Gift Certificates will expire one year from date of issuance.

3.) Responsibilities of AAA Arizona, Inc.:

- a. Client will receive (i) printable registry announcements to include in engagement announcements, shower invitation, and "save the date" wedding announcements and (ii) email registry announcement to forward to their guests. AAA Arizona, Inc. suggests advising guests of the Registry at least 120 days prior to honeymoon departure date. This will allow guests at least 30 to 60 days to contribute prior to the final payment date.

- b. Client will receive an email update alerting Client that a contribution has been made to the Registry.
 - c. Client will receive an online honeymoon registry page.
 - d. AAA Arizona, Inc. serves as the Client's travel agent based upon the Client's request to use Registry services, which requires that AAA Arizona, Inc. perform the following tasks on Client's behalf.
 - i. Make all of the arrangements for the Client's honeymoon package.
 - ii. Retain all of the Client's Gift of Travel Electronic Gift Certificate purchases on account, until they are applied to the travel package final payment, auxiliary items or "Paper" Gift Certificate as explained above.
- 4.) Cancellations, Refunds and Credit Card Chargeback's:
- a. In the event of a cancellation or postponement of a honeymoon, or any other similar circumstance which may create the need for a refund or return of any or all of the Gift of Travel Electronic Certificate(s) within the Client's Registry, AAA Arizona, Inc. will refund to the purchaser(s) all Gift of Travel Electronic Gift Certificate(s) that have not been applied to final payment to the original form of purchased payment.
 - b. In the event that these funds have already been disbursed to the Cruise line, Tour Company or other travel related vendor(s) and cancellation penalties have been assessed; refunded amounts received by AAA Arizona, Inc. from the vendor(s) will be disbursed in the following manner.
 - i. The Client (depending on amount of refund directly received from vendor(s), due to payments processed on credit card) will only be refunded up to the Client's actual amount paid to vendor via AAA Arizona, Inc. by check/cash less imposed vendor (s) penalties. Check refunds will be issued to whom paid amount(s) was received by AAA Arizona, Inc. In the event cash was received from the Client, refunded amount will be divided in half and sent to each individual listed on agreement.
 - ii. If any amount after is still remaining, AAA Arizona, Inc. will issue a "Paper" Gift Certificate in the name of the Client. The amount of certificate will still be within contractible agreement in regards to chargebacks and other fees after issuance.
 - c. Chargebacks and /or disputed transactions originated by purchaser (s) will be deducted from either of the following: remaining Gift of Travel Electronic Gift Certificates not applied to final payment or AAA Arizona, Inc. "Paper" Gift Certificate amount before or after issuance.
 - d. Changes or cancellations may result in additional fees imposed by the vendor. Penalties will be explained at time of deposit.
 - e. Registry processing fees and vendor change or cancellation fees may deducted by AAA Arizona, Inc. from the amount of the refund or the AAA Arizona, Inc. "Paper "Gift Certificate.

TERMS OF USE FOR CONTRIBUTOR

The Gift of Travel Honeymoon Registry Service by AAA Arizona, Inc. provides these Terms of Use (“Agreement”) to you as a user of www.aaa.com/honeymoon. By using **The Gift of Travel Honeymoon Registry Service by AAA Arizona, Inc.** you are indicating your willingness to be bound by all of the terms of this Agreement.

Conditions of Use:

- a. When a honeymoon couple utilizes the Gift of Travel Honeymoon Registry Service by AAA Arizona, Inc. all Gift of Travel Electronic Gift Certificate(s) purchases will be applied to either a travel package or other auxiliary items of the couple’s choice. AAA Arizona, Inc. Gift of Travel Electronic Gift Certificate has no cash value and can only be redeemed for travel store purchases at AAA Arizona, Inc. locations.
- b. The honeymoon couple will be required to pay the remaining amount due to vendor (s) for final payment.

Cancellations and Refunds:

- a. In the event of a cancellation or postponement of a honeymoon, or any other similar circumstance which may create the need for a refund or return of any or all of the Gift of Travel Electronic Gift Certificates within the client’s Gift of Travel Registry by AAA Arizona, Inc. AAA Arizona, Inc. will refund to the purchaser(s) all certificate(s) that have not been applied to final payment to the original form of purchased payment.
- b. In the event that these funds have already been disbursed to the Cruise line, Tour Company or other travel related vendor(s) and cancellation penalties have been assessed; refunded amounts received by AAA Arizona, Inc. from the vendor(s) will be disbursed in the following manner.
 - i. The client (depending on amount of refund directly received from vendor(s), due to payments processed on credit card) will only be refunded up to their actual amount paid to vendor via AAA Arizona, Inc. by check/cash less imposed vendor(s) penalties.
 - ii. If, any amount after is still remaining; AAA Arizona, Inc. will issue a “Paper” Travel Gift Certificate in the name of the client. Amount of “Paper” Travel Gift Certificate will still be within contractible agreement, in regards to chargeback’s and other fees after issuance.

AAA Arizona, Inc. reserves the right to change the terms and conditions of this Agreement at any time and without prior notice to you. Such changes will be effective once they are posted to this site. You agree to be bound by all of the terms of this and all future Agreements, as long as you use **The Gift of Travel Honeymoon Registry Service by AAA Arizona, Inc.**
