AAA Travel Best Vacation Photo Contest 2009  
Official Rules

**1. Eligibility:** No purchase or payment necessary to enter or win. Purchase does not increase odds of winning. Open only to legal residents of the United States who are 18 years of age or older at the time of contest entry. Any determination(s) of eligibility will be made by AAA Arizona, Inc. ("Sponsor"), whose decisions are final. Employees, officers and directors of Sponsor, ABC15 (KNXV-TV), their affiliates, subsidiaries, advertising and promotion agencies (collectively, the "Promotion Entities"), and the immediate family members (spouses and parents, children, siblings and their spouses, regardless of where they live) or members of the same households (whether related or not) of such employees, officers and directors are not eligible to enter. Void where prohibited by law or internal business or company policy. All applicable federal, state, and local laws and regulations apply.

**2. To Enter:** Submit a black and white or color vacation photo online at [aaa.com/contest](http://aaa.com/contest) between October 16, 2009 and November 6, 2009. You may submit up to 5 vacation photos, which have a maximum file size of 2mb each. Only personal vacation photos taken by the person entering the contest will be eligible. Sponsor reserves the right to disqualify or reject any photo submissions for any reason. You must be at least 18 years of age to enter. Five finalists will be selected by a panel of five judges, including noted photographer, Kerrick James, from the eligible pool of photos submitted based on quality, taste and adherence to the vacation theme. The five finalists' photos will be available for a popular vote between November 16, 2009 and November 27, 2009 at [aaa.com/contest](http://aaa.com/contest). The person who submitted the photo receiving the most votes will be the grand prizewinner.

**3. Prize:** A grand prizewinner will be selected on or before December 1, 2009. A total of one (1) Grand Prize will be awarded. The Grand Prize will be awarded and may be substituted at the sole discretion of Sponsor.

The Grand Prize will be awarded at the end of the Contest Period. A total of one (1) Grand Prize will be awarded consisting of the following:

One (1) person will receive a AAA Day Trip Photo Safari with Kerrick James, choosing one trip from available scheduled departure dates - 1/21/10 or 2/24/10. Prize includes 11- to 13-hour AAA day trip hosted by Kerrick James, transportation round trip from AAA Headquarters office at 3144 N. 7<sup>th</sup> Ave. and lunch.

Grand Prize value is \$299.

Travel Prize Conditions & Restrictions:
