AAA Travel WE KNOW DISNEY Sweepstakes
Official Rules

1. Eligibility: No purchase or payment necessary to enter or win. Purchase does not increase odds of winning. Open only to legal residents of the Arizona who are 18 years of age or older at the time of travel. Any determination(s) of eligibility will be made by AAA Arizona, Inc. ("Sponsor"), whose decisions are final. Employees, officers and directors of Sponsor, their affiliates, subsidiaries, advertising and promotion agencies (collectively, the "Promotion Entities"), and the immediate family members (spouses and parents, children, siblings and their spouses, regardless of where they live) or members of the same households (whether related or not) of such employees, officers and directors are not eligible to enter. Void where prohibited by law or internal business or company policy. All applicable federal, state, and local laws and regulations apply.

2. To Enter: Entry forms will be available starting Tuesday, July 6, 2010 and ending Tuesday, October 26, 2010 at all AAA Arizona locations and online at www.AAAaz.com/disney. Entry forms must be completed in full. Sponsor is not responsible for lost, late, incomplete, invalid, illegible, unintelligible or misdirected registrations, all of which will be disqualified. Limit one entry per person per week.

3. Prize/Odds of Winning: A weekly winner will be selected every Monday beginning July 12, 2010 through November 1, 2010. The Grand Prize winner will be selected on or before November 5, 2010 from all eligible entries submitted. A total of seventeen (17) weekly prizes and one (1) Grand Prize will be awarded. Odds of winning the Grand Prize depend on the number of eligible entries received during the Contest Period. The Grand Prize will be awarded and may be substituted at the sole discretion of Sponsor.

Each weekly prize winner will be awarded (4) 2-day Disneyland® Resort Park Hopper tickets. Approximate Weekly Prize value is \$776

The Grand Prize will be awarded at the end of the Contest Period. A total of one (1) Grand Prize will be awarded consisting of the following:

One (1) person will receive a 5-day/4-night Disneyland® Resort Vacation for four including accommodations at one of the Hotels of the Disneyland® Resort and a five day Park Hopper ticket for a family of four. Prizes do not include transportation to or from the Disneyland® Resort.

Approximate Grand Prize value is \$2,500.

Travel Prize Conditions & Restrictions:

- Winner must be at least 18 years of age at time of travel.
- Disneyland® Resort Park Hopper tickets must be used by May 31, 2011

If the notification to the winner is returned as non-deliverable, or if the winner is found to be ineligible or not in compliance with these Official Rules, such winner will be disqualified and an alternate winner will be randomly selected from the remaining eligible entries. Sponsor is not responsible for notification failure due to address inaccuracy, notification being lost in the mail, or any other failure or problem of any kind related to notification.

Sponsor shall not be liable to winner or any person claiming through winner for failure to supply the Grand Prize or any part thereof, by reason of any acts of God, any action(s), regulation(s), order(s) or request(s) by any governmental or quasi-governmental entity (whether or not the action(s), regulations(s), order(s) or request(s) prove(s) to be invalid), equipment failure, terrorist acts, air raid, blackout, act of public enemy, earthquake, war (declared or undeclared), fire, flood, epidemic, explosion, unusually severe weather, hurricane, embargo, labor dispute or strike (whether legal or illegal) labor or material shortage, transportation interruption of any kind, work slow-down, civil disturbance, insurrection, riot or any other cause beyond Sponsor's sole control.

5. Prize redemption: Weekly prize winners will be awarded (4) 2-day Disneyland® Resort Park Hopper Passes. AAA is not responsible for lost or stolen Disneyland® Resort Park Hopper Passes. The Grand Prize winner will be awarded one AAA Travel certificate, representing the prize elements described herein, redeemable for confirmation of trip at AAA Travel.
